This provides an opportunity for the JPO to be directly involved in multiple linkages with a variety of external partners working on radically reorienting health systems towards PHC in countries across the world (in keeping with PHC prioritization by WHO). The JPO will take part in its activities as defined by the current Policy and Partnerships Springboard Plan 2023. During the assignment, the JPO will contribute to the major endeavours of the unit which includes implementing a living partnerships strategy for PHC with internal and external partners; supporting the WHO-UNICEF leadership on the PHC Accelerator of the Global Action Plan for SDG3; communication and advocacy on PHC working closely with central communications; technical work on PHC with key WHO departments; and PHC focused linkages with Global Fund activities.
