# Organizational context

UNAIDS Country Office in Pakistan is a multi-country office based in Islamabad, Pakistan that also covers Afghanistan as a non-resident member of the UN Country Team there.

Provide leadership and coordinate support for an expanded UN system response to support countries towards ending the AIDS epidemic as part of the Sustainable Development Goals. To promote, support and provide guidance to national partners and the UN system in reaching Global AIDS targets by 2020 with a Fast-Track approach to rapidly scale up HIV services focused on populations and in locations most affected by the epidemic. Promote effective use of strategic information and documentation of trends on the epidemic and the response as well as provide intellectual leadership on the status of the response to HIV in the country.

The United Nations Joint Team on AIDS in Pakistan and Afghanistan are comprised of UN agencies active in the HIV response in the country and represents one of the largest Joint Teams on AIDS in the Asia-Pacific Region. The Programme Officer (JPO) will be tasked with assisting the UNAIDS Country Office in supporting the coordination of the two UN Joint Team on AIDS and the accompanying Joint Programme of Support for 2022-23.

## Content and methodology of supervision:

As part of the UNAIDS JPO programme overall framework, the JPO will benefit from the following supervision modalities:

- Structured guidance provided by the supervisor, especially in the beginning of the assignment, with the purpose of gradually increasing the responsibilities of the JPO.
- Establishment of a work plan, with clear key results (Performance Evaluation Reports).
- Effective supervision through knowledge sharing and performance/development feedback throughout the assignment.
- Easy access to the supervisor.
- Mentoring and supervision modality will be tailored to the needs and professional interest of JPO.
- Coaching on building confidence and professionalization in the UN system and international working arena while learning and respecting local culture and systems.
- Participation in Unit/Team/Office meetings to ensure integration and operational effectiveness.
- Guidance and advice in relation to learning and training opportunities within the field of expertise.
- Regular calls organized by the Human Resources Department (individually and/or as a group) to establish a community of practice and provide networking opportunities for JPOs. Specific emphasis is set on mentoring and supporting first-year JPOs.

# 1. Key responsibilities

Under the direct supervision of the UNAIDS Country Director (UCD) for Pakistan and Afghanistan, and subject to the changing working environment and partnership with government, the incumbent will:

- Assist the UCD and the UNAIDS Country Office (UCO) team in convening, coordinating, and facilitating the two Joint UN Team on AIDS (JUNTA / Joint Team) for Pakistan and Afghanistan.
- Assist the UCD, the UCO team and the two Joint Teams (JUNTAs) in developing and implementing a needs-based, country-tailored Joint UN Plan on AIDS, in support to the and the SDG commitments, strategies and plans, in accordance with the priorities of the United Nations Sustainable Development Cooperation Framework (UNSDCF).

- Support the UCD/ UCO and the two Joint Teams in their engagement in the development, implementation and reporting on UNSDCF; assist in making sure that country priorities and needs pertinent to ending the AIDS epidemic are fully integrated in the UNSDCF processes.
- Assist efforts of the UCO team to foster collaboration and inclusive partnerships with key stakeholders at the national and provincial levels (Government Ministries, AIDS Control Programmes, communities and other civil society organisations, development partners, private sector and others) to advance the rights and ensure equitable access to prevention, treatment and other essential services, with a particular attention to key populations such as people living with HIV, people who inject drugs, men who have sex with men, sex workers, transgender people, prisoners, migrant workers and others, women including intimate partners of men who engage in high risk behaviour, young key populations, as determined by the country context and up-to-date evidence.
- Support the UCD and UCO team in the development of a good knowledge base on legal, human rights and gender-related issues in relation to key populations. Liaise with appropriate departments in Government, civil society organizations and communities for collecting and sharing a broad range of strategic information that are relevant for key populations in Pakistan and Afghanistan.
- Assist the UCO in ensuring that civil society organizations and communities have space to engage in decision-making processes, participate fully in key partnerships and have access to financial and material resources made available by the Global Fund to Fight AIDS, TB, and Malaria (GFATM) and other funding agencies.

#### Learning Elements:

Upon completion of the assignment, the JPO will be able to:

- Fully understand the mission, the values, the strategic priorities, and the operating modalities of UNAIDS Joint Programme; demonstrate a profound understanding of the role, objectives, and operations of UNAIDS Cosponsors and the Secretariat in Pakistan and Afghanistan.
- Demonstrate a good understanding of the HIV epidemic, its main drivers and impact on various populations, key principles, and core priorities of the HIV response; demonstrate a thorough knowledge of the AIDS epidemic in Pakistan and Afghanistan, its implications, priorities of the national response, and the place and the contribution of the HIV response to the national and provincial health and development agendas.
- Demonstrate a good understanding of the Agenda 2030 for Sustainable Development; show ability to explain the linkages between the target of ending the AIDS epidemic under the SDG3 and other Sustainable Development Goals (SDGs).
- Follow up discussions on technical issues on HIV with counterparts to help promoting HIV-related policies and programmes, at national and sub-national levels.
- Demonstrate competence in 'translating' strategic information into people-centered programmes and interventions, in particular as relates to key populations.
- Demonstrate ability to engage effectively with civil society and community partners.
- Demonstrate proficiency in the development of the Joint UN Plan on AIDS and in the application of the 'Three Ones' principles of coordination; demonstrate ability to integrate provisions pertinent to ending the AIDS epidemic in the UNSDCF.

• Demonstrate good understanding of the UN reform, its implementation at country level, as well as the role and the contribution to the reform processes of UNAIDS Joint Programme.
