# Background information on UN Environment and the requesting Unit

The United Nations Environment Programme (UNEP) is the leading global environmental authority. It sets the global environmental agenda, promotes the coherent implementation of the environmental dimension of sustainable development within the United Nations system, and serves as an authoritative advocate for the global environment. This consultancy is in UNEP's Industry and Economy Division, Mitigation Branch, Climate Change Mitigation Unit.

The Climate Change Mitigation Unit manages a portfolio of Global Environment Facility (GEF) climate change mitigation projects in developing countries throughout the world. The projects, which are in various stages of development (concept, design, implementation, closure), are executed by different partners (Ministries, NGOs, etc.). The Unit, in its role as GEF agency, provides project oversight and ensures adherence to GEF and UNEP guidelines.

The Climate Change Mitigation Unit works with the GEF to fulfil the UNFCCC mandate in developing countries. Through investments from the GEF to the recipient countries, the Unit is instrumental in implementing projects with national governments that address the issues of policy, regulatory approaches, financial mechanisms, institutional capacity, innovation, private sector engagement, international cooperation and information dissemination. These are pivotal for addressing climate mitigation issues across different sectors.

The GEF projects, which are aligned to country national climate strategies such as their periodic national communication reports, national energy and environmental agendas and more recently the national determined contributions, are collectively contributing to the global 2050 net zero emissions target. The key thematic areas of these projects are renewable energy, energy efficiency, green financing, enabling activities, transparency and global impact programs in cities and mobility.

Through its expertise and regional presence in Africa, Asia, Europe, and Latin America and the Caribbean, the Climate Change Mitigation Unit together with UNEP initiatives are working closely with governments and diverse partners to implement a portfolio of USD 280 million worth of GEF investments to foster global environmental benefits in the fight against climate change. This involves 96 active projects in 109 countries.

# Why is the Junior Professional Officer requested/needed?

The world is facing a triple planetary crisis of climate change, nature and biodiversity loss, and contamination and waste. And these issues are interlinked; for example climate change is one of the key drivers of biodiversity decline. To address these challenges and achieve the objectives of the Paris Agreement and the targets of the Kunming-Montreal Global Biodiversity Framework, it is essential that countries accelerate efforts to achieve net-zero economies, in a way which is positive for nature.

As the environmental challenges that the world and countries face grow, there is an evergrowing need to be more impactful and strategic with the limited resources available to stimulate the needed transition to a net-zero nature-positive future. Multilateral strategic thinking and planning, and the consequent implementation of such strategic plans through aligned projects and investments, is key in this regard.

The Junior Professional Officer is requested to lead the development and implementation of internal strategies related to UNEP's GEF climate mitigation programming. Through the development of these strategies and subsequent implementation, the aim is for UNEP and GEF to enhance the impact and effectiveness of its climate finance programming, triggering through strategic investments net-zero nature-positive transitions in developing countries at scale. The Junior Professional Officer will also develop new climate change mitigation projects aligned with this strategy, and supervise existing GEF mitigation projects under implementation.

The Junior Professional Officer is requested for a two-year period.

# **Supervision**

The Head of the Climate Change Mitigation Unit will directly supervise the Junior Professional Officer. The Junior Professional Officer will use the e-performance system, preparing an annual workplan and being appraised by the Head of Unit as the first reporting officer. The second reporting officer will be the Chief of the Mitigation Branch.

# Content and methodology of the supervision

The Junior Professional Officer will be integrated into an existing team of the unit, consisting of programme and financial officers, working on unit strategy and management issues. The team meets weekly through fixed coordination meetings and also holds additional meetings to focus on specific topics.

Supervision activities will include:

- First day: giving the Junior Professional Officer a 26-page welcome pack document describing UNEP, the GEF, the institutional structure, the team, work flows, etc. Presentation to the office groups, office building and desk.
- Hybrid welcome meeting, including presential and online colleagues from all regional and country offices
- Formal presentation/introduction of the Junior Professional Officer to the Branch Chief, Division Deputy Director and Division Director.

- Development of a e-performance plan for year one (and subsequently year two), including professional development and learning plan and proposed travel calendar. In this meeting the Junior Professional Officer will discuss with the First Reporting Officer the General objectives, desired results and anticipated problems related to the position.
- Minimum monthly one-on-one meetings with the First Reporting Officer to discuss performance, development and training, and job satisfaction, as well as semesterly detailed (1.5 hour) appraisal meetings at mid-term and end of workplan.
- Execution of workplan activities: the incumbent will perform the duties under the supervision of the First Reporting Officer and to consult with this person on issues of policy or other sensitive matters. The final results of each set of activities will be reviewed by the First Reporting Officer with regards to attainment of objectives and quality of work.
- Annual presentation by the Junior Professional Officer to the Unit on achievements, experiences, good practices and lessons learned related to implementing the workplan.

Terms of reference

The strategy will be based on an inclusive consultative process and draw upon a mapping of cross-division and cross-focal point collaboration for integrated solutions, identification of key impact countries and development of an action plan.
- As part of the strategic planning exercise, undertake missions to hold regional consultations in the UNEP regional offices in Africa, Asia and the Pacific, Eastern Europe and Latin America and the Caribbean.
- Support the strategy's implementation by drafting annual Unit workplans aligned with the strategy.

# Project identification and development

- identify and develop new portfolio of new climate change concepts based on the expressed needs of countries and relevant intergovernmental decisions.

# Qualifications and experience

<u>Education</u>: Advanced university degree (Master's degree or equivalent) in climate mitigation, climate finance, energy, management, development, economics or law. A first-level university degree in combination with four years of qualifying experience may be accepted in lieu of the advanced university degree.

<u>Work Experience</u>: At least 4 years at the national level, or 2 years at the international level in managing or developing climate mitigation projects in developing countries is required.

<u>Languages</u>: English and French are the working languages of the United Nations Secretariat. For the position advertised, fluency in English (oral and written) is required.
