#### **Organizational Setting**

The main aim of the FAO country offices, which are headed by an FAO Representative, is to assist the government to develop policies, programmes and projects, to achieve food security and to reduce hunger and malnutrition, to develop the agricultural, fisheries and forestry sectors and to use their environmental and natural resources in a sustainable manner. FAO Pakistan seeks to support the 2030 Agenda through the transformation to efficient, inclusive, resilient and sustainable agri-food systems for the four betters (better production, better nutrition, a better environment, a better life), and leaving no one behind in Pakistan. The Country Programming Framework (CPF) outlines three priority areas that will guide FAO's partnership with the Government of Pakistan for the next five years:

- 1. Basic Social Services
- 2. Climate Change and the Environment
- 3. Sustainable Inclusive Economic Growth and Decent Work

FAO Pakistan's largest contribution will be in addressing the challenges of climate change and the environment in agriculture, food security and related aspects. At the policy and institutional level, it will actively contribute to protect and sustainably exploit the Indus Basin, as well as ensure the sustainability of marine ecosystems. FAO Pakistan will also prioritize the promotion of sustainable rural livelihoods to support sustainable inclusive economic growth and decent work. Another significant contribution of FAO will be in strengthening food and nutrition systems to address the "leaving no one behind" agenda, including through social protection.

The post is located in the FAO Representation in Islamabad, Pakistan, with frequent travel to the field, especially Multan and Hyderabad.

- Collaborates in the development of training tools and materials and the organization of workshops/seminars, etc.;
- Participates in the organization, conduct and follow-up of meetings, consultations and conferences, the development/production of required materials and the provision of information and assistance to partners.

- Supports the development of work/implementation plans and contributes to monthly, biannual and annual progress reports for the relevant programme projects;
- Assists with the development of training materials with the project team and provides training to farmers and/or farmer field school facilitators:
- Supports the development of concept notes for events/workshops and organizes events;
- Contributes to technical report/teaching material development for farmer field schools;
- Supports the coordination with internal stakeholders and ensures synergy across different programme and projects;
- Performs other related duties as required.

- Advanced university degree in relevant area such as agriculture, crop science, agricultural economics, food and nutrition, food technology or related fields.
- Three years of relevant experience in research or project implementation of agronomy, crop science, farm economy, eagriculture or other relevant fields.
- Working knowledge (proficient level C) of English and limited knowledge (intermediate level B) of another FAO official language (Arabic, Chinese, French, Russian or Spanish).
