Organizational Setting

The main aim of the FAO country offices, which are headed by an FAO Representative, is to assist the government to develop policies, programmes and projects, to achieve food security and to reduce hunger and malnutrition, to develop the agricultural, fisheries and forestry sectors and to use their environmental and natural resources in a sustainable manner. FAO, as a member of the UN Sustainable Development Group (UNSDG), is fully committed and engaged in the implementation of this collective interagency effort at all levels. Through the Hand-in-Hand Initiative, we are assisting policy makers in their plans to further leverage data, technology and innovation to meet the Sustainable Development Goal (SDG) targets by 2030.

FAO's activities in Papua New Guinea (PNG) are guided by the Country Programming Framework (CPF) 2018-2023 which sets out three priority areas: (i) Enhancing equitable, productive and sustainable natural resource management; (ii) Strengthening resilience for food security and nutrition; and (iii) Sustainable and inclusive economic development and job creation in rural areas. FAO PNG has been conducting activities under 18 projects with a total budget portfolio of USD 66 million. Projects are focusing on national capacity building in natural resources management (forest, marine fisheries, landscape) and addressing climate change (CPF priority area 1); focusing on capacity building in food security and nutrition (priority area 2); and improving livelihoods and inclusive economic development (priority area 3).

The post is located in the FAO Representation in Port Moresby, Papua New Guinea.

Technical Focus

The Junior Professional Officer assists with the development and implementation of programmes and activities related to natural resource management in Papua New Guinea.

- Participates in the development of improved work methods, tools and systems;
- Updates databases and web pages;
- Participates in multidisciplinary project/work teams;
- Collaborates in the development of training tools and materials and the organization of workshops/seminars, etc.; and

Specific Functions

- Supports gathering, processing, analysing and diffusing information related to the Enabling Green Growth in Papua New Guinea to address climate change and conserve biodiversity project in an economically and socially efficient way;
- Contributes to corporate exercises for planning, monitoring and reporting on results achieved through projects implementation support and capacity development activities;
- Supports the review and monitoring the project budget, preparing requests and revisions as required; maintains and monitors budget expenditures and resources;
- Ensures the completeness and quality of data and documentation in the FAO corporate Enterprise Resource Planning (ERP) systems, for all assigned operational field projects and activities;
- · Performs any other related duties as required.

Minimum Requirements

- Advanced university degree in relevant area such as marine biology, fishery science or aquaculture, ocean science, economics, environmental studies, climate change, food and nutrition, food technology, veterinary sciences, gender policy, maritime law, food law, international law, trade law, rural development, anthropology, statistics, or related fields.
- Three years of relevant experience, including research or management of fisheries, policy development or implementation, food trade and markets, food safety and quality, field of statistics and data management of fisheries, monitoring and evaluation of policies and programmes.
- Working knowledge (proficient level C) of English and limited knowledge (intermediate level B) of another FAO official language (Arabic, Chinese, French, Russian or Spanish).
