1. Organisational Context

The International Fund for Agricultural Development (IFAD) is an international financial institution and a specialized United Nations agency dedicated to eradicating rural poverty and hunger. It does so by investing in rural people. IFAD finances programmes and projects that increase agricultural productivity and raise rural incomes, and advocates at the local, national, and international level for policies that contribute to rural transformation. **The External Relations Department (ERD)** brings this mission to life with external partners, growing IFAD's work, expanding its influence and keeping food systems and rural people high on the global agenda.

ERD leads IFAD's external engagement through public and political advocacy, global policy engagement, partnership building, resource mobilization and strategic communications. ERD also leads IFAD's Replenishment, which is the process through which IFAD mobilizes core funding from Member States and agrees on priorities and targets for the Fund's work during each three-year replenishment period.

ERD includes the Communications Division (COM), the Global Engagement, Partnership and Resource Mobilization Division (GPR) and Food Systems Coordination (FSC). Together, these teams:

- Deepen and expand political dialogue and engagement with IFAD's Member States and external partners;
- Diversify and grow IFAD's resources, including through leading on Replenishment and supplementary funds mobilization; and

 Strengthen and expand IFAD's global influence, visibility and reputation, including through global policy processes and growing IFAD's communication footprint and visibility in top-tier media.

The Global Engagement, Partnership and Resource Mobilization (GPR) Division has a specific focus on global engagement, partnerships, and on driving the resource mobilization efforts with traditional and non-traditional donors and partners. Within this framework, the GPR Division addresses three main functions:

- (i) Global engagement and multilateral relations;
- (ii) Strategic partnerships; and
- (iii) Replenishment and resource mobilization, including supplementary funds and blended finance.

The mission of GPR is to enhance IFAD's contribution to inclusive and sustainable rural transformation and Agenda 2030 through strengthening global engagement, partnerships and resources mobilization.

GPR has the following decentralized Liaison Offices:

- The Americas Liaison Office (ALO) with 2 offices based in Washington and New York, United States of America;
- The Saudi Arabia Liaison Office (SLO) with one office based in Riyadh, Kingdom of Saudi Arabia;
- The Japan Office (JLO) with one office based in Yokohama, Japan, and
- A newly established presence in Brussels (EU/BRX)

2. SUPERVISION

Direct supervisor: Chief Partnership Officer

Under the direct supervision of Chief Partnership Officer, the Junior Professional Officer (JPO) will carry out its function within the Resource Mobilization Unit of GPR and will support the effective implementation of the Supplementary Fund Resources Strategy and other tasks related to portfolio of supplementary funds and IFAD managed co-financing.

The JPO will prepare an annual work programme and performance plan reviewed by the supervisor. Supervision and feedback will be provided as needed to monitor and support his/her performance and professional growth. Mid-year review and annual review will help to analyse performance and plan personal development.

3. Purpose of position

Under the overall supervision of the Chief Partnership Officer, the JPO will:

 Act as liaison officer for the co-financing framework agreements that IFAD has entered into with various partners (e.g. Spain, CDP, Opec Fund, AFD), between the partner and IFAD

- Department of Country Operations, with the aim to ensure successful implementation of these agreements;
- Support the implementation of the Supplementary Resources Strategy Action Plan, and link
 additional IFAD's Executive Management Committee (EMC) mandated priorities, focusing
 for example on the remaining actions, which include integrating the results reporting of all
 the grants financed from supplementary funds in our systems, the development of specific
 procedures for the establishment and management of IFAD Trust Funds and IFAD-managed
 co-financing, and other tasks of increasing in-house awareness and visibility of the new
 procedures;
- Provide other support on tasks relating to resource mobilization and supplementary funds as required.

The level of responsibility assigned to the JPO will depend to a large extent on his/her willingness and capacity to learn, maturity, capacity and ability to take on new tasks over the period that he/she is in place.

Work may involve travel in IFAD Member Countries.

The work, which will involve the management of processes as well as strategic and analytical work, will require broad collaboration with colleagues within IFAD; government authorities; project staff; implementing partners; development partners and other stakeholders.

4. Qualifications and Skills Required

Education and experience:

- Advanced university degree from an accredited institution in international development, international relations, political science, public policy, social sciences, communication, economics, business management, or related disciplines.
- Degree must be an accredited institution listed on https://www.whed.net/home.php.
- Understanding of the operations and business model of IFAD, other UN agencies or international financial institutions would be an asset.
- Minimum of 2 years of progressively responsible professional experience in relevant field such as development and financial cooperation, outreach liaison and/or any resourcemobilization related activities, preferably in a multi-cultural organization or national organization providing support on a global scope.
- Experience in data-base administration and capacity to organize records and data into
 meaningful profiles for effective reporting will be an asset. Some working experience in
 rural development/food security issues in IFAD borrower countries will be an advantage.
 Understanding of political and budgetary processes and mechanisms in donor countries
 and of agricultural and rural development related issues are desirable.

- Written and verbal communication skills in French, Spanish, Arabic or other languages are an asset.

Training components:

- On the job training in work related areas on a wide range of new and emerging issues with a focus on delivering results and impact.
- Participation in trainings organised by IFAD and external training providers.
- Direct coaching by Chief Partnership Officer.

Learning Points

- The first year to acquaint him/herself with IFAD staff, corporate agenda policies and strategies, programmes and performance enhancing processes;
- Interact and collaborate with Partnership Officers (PO) to gain hands-on experience in working with IFAD donor countries and partner organizations;
- Support the engagement of POs with the Department of Country Operations (DCO) and Office of Technical Delivery (OTD) to support their needs for partnerships and resource mobilization;
- It is expected that by the end of the two years the JPO will be able to articulate IFAD's vision
 in key thematic areas related to rural development; in written and oral presentations;
 contribute to review partnership documents according to IFAD procedures.
