

Sanitation and Water for All (SWA) is a global partnership hosted by UNICEF, with nearly 500 partners, including almost 90 UN Member States, donors, civil society organizations, the private sector, research and learning organizations, utilities and regulators, UN agencies, and other development partners. The partnership works to catalyze political leadership and action, improve accountability, and advocate for the effective use of resources to achieve universal access to water supply and sanitation.

The partnership's secretariat coordinates partners to encourage ambitious political action for water, sanitation and hygiene, mutual accountability, and common messaging to influence decision-makers globally and nationally.

SWA's ultimate goal is universal access to water supply and sanitation for all, always and everywhere, focusing on three strategic objectives:

- Building and sustaining political will to eliminate inequalities in water, sanitation, and hygiene
- Championing multi-stakeholder approaches towards achieving universal access to services
- Rallying stakeholders to strengthen system performance and attract new investments

SWA's mission statement emphasizes the need to eliminate gender-based inequalities in access and the critical role of women and girls in achieving this. The partnership focuses on the hardest-to-reach and most vulnerable individuals, communities, countries, and regions, putting women and girls at the center as dynamic agents of change, not just as passive recipients.

The SWA, together with the Governments of the Netherlands, UK as well as UNICEF and IRC WASH, recently launched the Heads of State Initiatives (HOSI), which are a collection of flagship programs led by the highest leaders in government to ensure the achievement of the water, sanitation, hygiene and related targets of the SDGs. These initiatives are being developed in more than 10 countries, with three countries already having launched Presidential Compacts or similar initiatives. The partnership also organizes regular high-level meetings including Finance Ministers' Meetings as well as Sector Ministers' Meetings, both of which are co-convened with UNICEF. These convenings are important platforms for taking stock of progress on SDG6, identifying gaps which can be addressed by high-level political action and building partnerships across different stakeholder groups to achieve the plans as well as improving mutual accountability among stakeholders.

The JPO will support this mission by providing political analysis and research on opportunities for strengthened political engagement in SWA partner countries across Africa, Asia, Europe and Latin America. This political research and analysis will contribute to the development of country and partner specific strategies to be implemented over a course of two-three years. The JPO will contribute to the preliminary research, analysis and strategy development and will support the roll out of the plans by mobilizing partners through online and inperson meetings, preparing reports, and supporting different senior team members with follow-up activities. The JPO will also be actively involved in the preparation of the upcoming high-level meetings in particular the Sector Ministers' Meeting in 2025 which will also aim at mobilizing a few Heads of State and Government. The JPO will contribute to preparing SWA's participation in the subsequent UN Water Conference in 2026.

#### 1.)What purpose it serves

JPO will providing preliminary political research and analysis to support the Heads of State Initiatives as well as contribute to mobilising partners including government participants at ministerial level to prepare for, and attend the SWA high-level meetings and support a robust follow-up.

#### 2.) What is it accountable for

Under the direct supervision of the Programme Specialist, Country Engagement, the JPO will be responsible for key functions, including: [max 3 to 4 key functions]

- Preliminary research and analysis, and development of recommendations for country and partner specific engagement strategies on the Heads of State Initiatives this will help to identify countries of interest, political feasibility of the initiative and a potential list of countries to be involved
- Prepare draft plans for partner mobilization ahead of SWA high-level meetings to ensure information is properly conveyed and agencies are regularly engaged and develop briefings for their ministers.
- Document the results of engagement in the Heads of State Initiatives as well as the high-level meetings, with a view to strengthen peer-to-peer learning and inspire more partners to participate in these initiatives and programmes
- Organise regular online and in person convenings to ensure coordination among partners and with the Secretariat on SWA strategic actions and workplans.

The JPO will work closely with the Programme Specialist, Country Engagement to strengthen political research, analysis and partner engagement in support of the partnership's Head of State Initiatives and the High-level Meetings:

- 1. Researching, analysing and preparing recommendations for country and partner specific strategies on the Heads of State Engagement
- 2. Preparing plans for partner mobilisation ahead of the Sector Ministers' Meeting and other SWA convenings
- 3. Mobilising partners to participate in the Heads of State Initiatives and the high-level meetings
- 4. Organizing online and in-person meetings for partners to share lessons, identify areas of action and follow-up on the Heads of State Initiatives and high-level convenings
- 5. Documenting partner experiences and preparing learning notes to increase peer-to-peer learning on the Heads of State Initiatives and high-level convenings.
- 6. Supporting the Program Specialist, Country Engagement in developing strategies and follow up on key initiatives.
