Organizational Setting

The Terrestrial Environmental Radiochemistry (TERC) Laboratory assists IAEA Member States in enhancing the quality of their analytical measurements of radionuclides, trace elements and stable isotope ratios for monitoring and assessment of environmental pollution and climate change. This is accomplished by provision of reference products, such as matrix reference materials, validated procedures, proficiency tests, and guidelines for environmental protection, and through coordination of laboratory networks and training activities. Contributing to the IAEA Technical Cooperation programme, TERC supports the Member States in their development and capacity building by improving preparedness for emergency situations, analytical quality in Member States laboratories and providing training.

Main Purpose

Under the supervision of the Laboratory Head, the Training and Outreach Associate officer will support the training and outreach activities for the capacity building of Member States. Focus will be on the development of training materials and curriculum and on outreach activities for the TERC laboratory. The incumbent will also interact with visitors to the TERC Laboratory including fellowships and internships from Member States.

Role

The Training and Outreach Associate officer will: (i) develop training materials and curriculum based on technical resources provided by the TERC team, (ii) support outreach activities including in support to the Worldwide Proficiency Test exercise with over 500 participants, (iii) support fellowships and internships to the TERC Laboratory and (vi) communicate the activities of the TERC laboratory through promotional materials, website articles and social media.

Partnerships

The Training and Outreach Associate officer will work as part of a team in a multidisciplinary environment at TERC and will interact with other IAEA laboratories. She/he will also collaborate with colleagues in provision of training.

Functions / Key Results Expected

- Develop training materials and curriculum for teaching aspects of environmental monitoring to Member States.
- Provide support to outreach activities including the Worldwide Proficiency Test including assisting in the organisation arrangements and organising the training activities.
- Support fellowships and internships at the TERC Laboratory.
- Develop promotional material, website activities and social media that promotes the capacity building activities of the TERC Laboratory.
